Entries must be received by the Contest Sponsor within the Contest Period in order to be eligible to win.

## **Entrant Eligibility**

- The Contest is open to all members of Servus Credit Union who: (a) are legal residents of Canada (excluding Quebec) and (b) are <u>not</u> employees, retirees or representatives of the Contest Sponsor or their respective affiliates, subsidiaries, related companies, agents, associates, dealers, representatives, advertising or promotional agencies or members of the immediate families of those employees and retirees or any persons with whom they are domiciled.
- Members under the age of 18 are not eligible for The Contest.

### C. Alternate method of entry:

#### First Prize:

There is one (1) First Prize available to be won, consisting of a trip with a total approximate retail value of \$20,000 CAD. If the cost of the trip is less than \$20,000 CAD, a statement credit for the difference will be issued to the winner's Mastercard to cover additional travel expenses.

Eligible winner(s) may opt for a prize of a statement credit valued at \$10,000.

The Contest draw for the prize will be made on or before November 15, 2025, at 9:00 am Mountain Standard Time.

Locations under sanction by the Canadian Federal Government are excluded from the grand prize travel destination.

### **Limitation of Liability:**

By accepting the prize, the winner agrees that Servus Credit Union is not responsible for and shall not be liable for any loss, injury, damage, delay, accident, cost, or expense that may occur in connection with the acceptance, use, or misuse of the prize, including travel to and from the destination and participation in any activities related to the prize. #### **Secondary Prizes:**

Nine (9) \$250 statement credits will be awarded throughout the campaign. Eligibility: Spend a minimum of \$200 per month on groceries. Eligible MCC is categorized as "Grocery Stores and Supermarkets" (MCC 5411).

Winners will be featured in campaign communications.

The Contest draw for the secondary prizes will be made on a monthly basis on or before the 5<sup>th</sup> day of the following month, at 9:00 am Mountain Standard Time in the months of September, October, November.

The prize will be issued by Servus Credit Union. To the extent permitted by law, the winner must also be available and consent to taking a picture with a Servus Credit Union staff member for Servus social media (Instagram, Twitter and Facebook) when they sign the Release and Indemnity Form.

A Servus Credit Union representative will randomly select potential winner(s) from all eligible entries received during the Contest Period. The odds of being selected as a winner are dependent on the total number of eligible entries received. The selected entrants will be verified and then contacted by a Servus Credit Union representative by telephone. In the event that a selected entrant cannot be contacted within forty-eight (48) hours, despite customary diligent efforts, they will be disqualified and another entrant chosen. The initial selected disqualified potential winner(s) will have no recourse toward the Contest Sponsor.

- If a potential winner cannot accept the Prize as awarded for any reason, his or her entry will be forfeited and another eligible entrant may be selected.

In that event, the Contest Sponsor may award a prize at random from among the eligible entries received up to the time of the impairment or cancel The Contest.

#### Law

These Contest Rules & Regulations constitute the complete terms associated with The Contest. The Contest is subject to applicable federal, provincial and municipal laws and regulations. ### **Disputes**

To the fullest extent permitted by law, all disputes, claims and causes of action arising out of or connected with the Contests, prizes or these Rules & Regulations will be resolved individually, without resort to any form of class action, and exclusively by the appropriate court of the Province of Alberta, Canada, in Edmonton, Alberta.

#### Language Discrepancy

In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules & Regulations and disclosures or other statements contained in any materials related to The Contest, including but not limited to point of sale, print or online advertising, these Contest Rules & Regulations shall prevail, govern and control.
